**Sunday test dates** are available (at limited locations) for students who cannot test on Saturday because of religious convictions. See each testing agency’s website for details and registration procedures.

**Fee Waivers:** SAT / ACT fee waivers are available to high school **juniors or seniors** who are either on “FREE” or “REDUCED LUNCH” (there are other ways to qualify based on family income and other factors). Students may receive up to 2 SAT and 2 ACT testing fee waivers and up to 8 College Application Waivers (4 from taking the SAT on a fee waiver & 4 more for taking the ACT on a fee waiver). See Ms. Gilman, our CAP Advisor, to request these fee-waivers and/or to determine if you are eligible.

**Other fees may be required for other services such as:**

- **Standby testing for the SAT & ACT IS NO LONGER AVAILABLE** - Students who miss the late registration deadline may be able to request **Waitlist Status**. **This does not guarantee you a seat on test day.** You will be admitted to the test center on a first-come, first-served basis, determined by when you arrive at the center, not on when you registered. This status may be available from the last (i.e late) registration deadline up until five days before test day. Test registration on test day at the test center ***is not available***. If admitted, you will be charged \$46.00 in addition to the \$52.50 registration fee for SAT testing & \$45 for ACT Standby testing in addition to ACT registration fees.
- **Change test type, test date, or test center for SAT** - Make the change no later than the Wednesday 2—3 weeks before your test date Changes to your test center or test date can be made online through your free account or by calling Customer Service. \$28.00
- **ACT - Change test date - \$22, to change your test center for ACT - \$23**
